She is the Special Rapporteur on Child Marriage and Other Harmful practices.

She is also the Country rapporteur for Burkina Faso, Cote d'Ivoire, Ethiopia, The Gambia, Ghana and Niger.

Hon. Kembo is a Legal and Judicial officer ( Magistrate) by profession and has served in the Government in various senior capacities. Using her expertise and experience, she plays a tremendous role within the Committee. She leads the activities of the Committee as it relate to child marriage and harmful practices in State Party reports, Communications and other activities of the Committee. She also takes the lead in following up the implementation of the provisions of the Charter, the decisions and recommendations of the Committee in the countries she is rapporteur to. Hon Kembo has authored 4 books. The first one is on the African Human Rights system, the second on Human Rights in criminal proceedings in Cameroon, the third on Parenting and the last on Human Trafficking and Smuggling. She has published articles, including on the evaluation of the Maputo Protocol, 18 years after, or on Child marriage in crisis situation.
